Be aware that this notice comes to you in your personal capacity We, the undersigned, support the office you now occupy when the actions of the official sworn to carry-out its duties are conducted lawfully. However, we despise those in positions such as yours who are violating our rights- whether due to ignorance or willful disobedience.

As you should know, the state and federal Constitutions have been created to restrain public servants such as yourself to performing only those powers specifically enumerated therein. Furthermore, the federal Constitution, as the Supreme Law of the Land, requires that all subordinate laws conform to it. Those made repugnant to it are null and void, and are not to be followed; nor are they to be enforced upon the People by their servants in government. We expect every public servant to have a proper understanding of the contract he or she has with us via his or her oath, and to stick to his or her chief responsibility, which is to protect *individual* rights.

Since April of 2020, your actions have caused irreparable harm to the people, organizations and businesses of Santa Clara county. We, our families, friends, and people in our communities, have suffered financial, emotional, relational and physical harm- even death- as a result of your unlawful actions.

Now, therefore, the notices attached to this letter, along with the *Demand and Order to Cease and Desist*, are presented to you by several of the naturally born, sentient people of Santa Clara county, California. They constitute direct, constructive lawful notice to you, personally and as a County of Santa Clara employee, as the principle, and to all of your subordinates, and to your and their replacements, successors, substitutes and agents. The purpose of this formal legal correspondence is to make you aware of our charges against you, our public servant, and to give you the opportunity to cure. These charges cover some, but not all, of your actual violations, including repeated violations of your oath of office. [The FBI takes these violations very seriously](#), so we want to allow you the Due Process right to correct them immediately and return to confining your actions to the limits placed upon you by the state and federal Constitutions.

In closing, know that we stand behind those who are abiding by their oaths and protecting individual liberties. The County Counsel has a valuable purpose in preserving liberties and a peaceful society. This is a high responsibility, not to be corrupted by ambitions of political and financial gain. Thus we urge you to take corrective action immediately so that peace, your job, your progeny and your freedom are preserved.
